Proposal Name/Brief Description: "Monarch Butterfly Habitat Preservation"

"Each fall, hundreds of millions of monarch butterflies migrate from the United States and Canada to mountains in central Mexico where they wait out the winter until conditions favor a return flight in the spring. The monarch migration is truly one of the world's greatest natural wonders yet it is threatened by habitat loss at overwintering grounds in Mexico and throughout breeding areas in the United States and Canada."

Underhill, Vermont provides important breeding and migratory habitat to Monarchs who perform the final leg of the multi-generational journey to their overwintering grounds in Mexico, approximately 3,000 miles from Vermont. However, local mowing and brush hogging schedules may be preventing monarchs from fully thriving within Underhill open spaces.

By designating land within and around the Town of Underhill as preserved monarch habitat, Underhill could provide a valuable safe haven for the migratory monarch for years to come. Preserving monarch habitat would primarily entail identifying areas that contain a good amount of sunlight, milkweed and native wildflowers, then altering local mowing / brush hogging schedules to accommodate monarch breeding/migratory schedules, which may shift subtly year to year, due to weather conditions and climate change. Further, the Underhill community would greatly benefit from educational kiosks at the designated monarch habitat areas. These kiosks would help raise awareness and provide education to locals who want to know more, understand how Vermont fits into the migratory patterns of the monarch and what local citizens can do to help.

Ideal locations for monarch preservation include: Casey's Hill and Tomasi Meadow, certain areas within Mills Riverside Park and the New Road landfill site.

<u>Casey's Hill/Tomasi Meadow and Mills RIverside Park</u> would each benefit from an attractive Vermont-made wooden kiosk with bench such as the following:

The TimberHomes Classic Kiosk would provide plenty of space (42"W x 32"H) to include maps of the monarch migration patterns as well as educational information about the lifecycle and current status of the monarch butterfly. It would also provide enough space to point out other relevant information about the habitat, plants and creatures of importance and a registration box for visitors to document their monarch and animal observations, as well as whether they take any monarch eggs or caterpillars for rearing. A brochure holder could contain guidelines on monarch rearing and milkweed seed gathering / germination. A basic kiosk would cost \$3,000 each with tax. A double-sided Kiosk with plexiglass signboard covers, brochure holder, registration box and an attached bench would cost approximately \$5,645 each\* including tax, but does not include site prep and installation.

Lead time: Ranges from 8 – 16 weeks depending on the season and demand.

\*Consider requesting Jericho to contribute towards the Mills Riverside Kiosk investment.

New Road Landfill Site would benefit from a nice Vermont-made wooden kiosk, such as the following:

The TimberHomes Mini Kiosk contains a 2'W x 3'H signboard. A basic mini kiosk would cost \$2,000 + tax. A double-sided kiosk with plexiglass signboard covers, brochure holder and registration box to document monarch and animal observations would cost approximately \$3,260 including tax, <u>but</u> <u>excluding site prep and installation</u>.

Lead time: Ranges from 8 – 16 weeks depending on the season and demand.

Total Kiosk Expense: Between \$8,348 + tax - \$14,898

Sitework and installation expenses are not included.
