Should a replacement wastewater system be required, a State wastewater permit must be obtained and copy of the Notice of Intent and/or permit must be submitted to the Zoning Administrator with a copy of the plans. All aspects of this Boundary Line Adjustment are to be completed in accordance with the Town of Underhill Unified Land Use & Development Regulations, as amended, and any & all federal and/or State regulations currently in effect. Once approved, notice of the permit is required to be posed in a conspicuous location on the property during the appeal period. The Town recommends that that notice be posted during the duration of the appeal period. The applicant and/or landowner is required to contact the necessary State agencies to obtain permits: (802) 477-2241			

(permit specialist). Interest persons have the right to appeal the approval of a permit to the Development Review Board within fifteen days (15) from the date of issuance.
