4:00 p.m. Call to order, adjustments to agenda. Meeting called to order by Pat Sabalis. Adjustments to agenda: Add discussion on Selectboard training, municipal policies and ordinances, audio options for Selectboard meetings and Randy Clark's offer to help with plantings in the Town Green at Park Street.

4:01 p.m. Public Comment Period. No members of the public in attendance. In recognition of the early start public comment will be permitted later in the meeting.

4:02 p.m. Organizational Meeting: In accordance with 24 VSA §871,

- Bob Stone nominated Pat Sabalis for Selectboard Chair. Pat Sabalis seconded and the motion passed by a vote of 2-0.

- Pat Sabalis moved to adopt the draft 2019-2020 schedule of regular meetings being held every the first Tuesday and the third Thursday of the month, with adjustments to the months of May, August and January. Stone seconded and discussion ensued. After discussion the motion passed by a vote of 2-0. Staff to post final schedule.
- Consensus is to have staff modify draft Rules of Procedure for action at the next Selectboard meeting.

Pat Sabalis moved to approve the request for an extension of the Access Permit #A16-08 issued August 2, 2016 under the same approval and conditions for a term of three years. Bob Stone seconded and the motion passed on a vote of 2-0.

Additions to Agenda. Recommended Selectboard training offered by Vermont League of Cities and Towns (VLCT) scheduled for March 30, 2019. Staff to collect municipal polices and ordinances for website and Selectboard members. Options to improve audio especially during Selectboard meetings held in the Town Hall Great Room to be identified by staff. Town Administrator to work with Tree Warden, Road Foreman and Randy Clark on proposal for planting in the Underhill Flats Town Green.

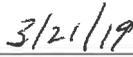
